- 1 No applications will be accepted after the July 10th deadline. Applying early is recommended.
 - 2 Partial participation will not be accepted. You must be present for the entire duration of the event. Once your participation has been confirmed, cancellations will not be accepted.
 - 3 Applicants for the JAPAN TENT Program must be eighteen (18) years of age or older, and only the applicants themselves may participate in JAPAN TENT. Family members of applicants cannot participate.
 - 4 The JAPAN TENT STEERING COMMITTEE will make all arrangements for round-trip transportation from the participants' home region in Japan to Ishikawa. (Highway buses will be used in many cases.)
 - 5 Participants must follow the instructions and rules of the JAPAN TENT STEERING COMMITTEE for the duration of the JAPAN TENT Program.
 - 6 The maximum number of participants is 300. If there are more than 300 applicants, the participants will be selected by lottery.
 - 7 We will notify you of the results of your application by the end of July.
