# Guidelines for Japanese Government (MEXT) Scholarship Students who wish to work part-time

Japanese government (MEXT) scholarship students (hereinafter referred to as "MEXT students") receiving scholarships from the Japanese government for their study and living must follow the procedures prescribed by Tottori University before engaging in part-time work to the extent that it does not interfere with their studies.

## 1. Desirable part-time jobs for MEXT students

- (1) Part-time work that contributes to students' studies and research activities
- (2) Part-time work performed in response to a request from a public agency
- (3) Part-time work that contributes to interaction with and contribution to the local community
- (4) Part-time work that contributes to international exchange and friendship between Japan and other countries
- (5) Part-time work that contributes to the improvement of Japanese language skills and understanding of Japanese society
- (6) Internships and other part-time jobs that contribute to future employment in Japan

## 2. Application Procedures

The Immigration Service Agency will grant permission to engage in an activity other than that permitted under the status of residence (hereinafter referred to as "the permission"), and Tottori University will also take the following procedures.

## (1) Prior application

MEXT students must apply for permission at the Immigration Services Agency after obtaining approval from their supervisor.

#### (2) Reporting the acquisition of permission

MEXT students must bring their passports and residence cards to the IAD after they obtain permission from the Immigration Services Agency.

## (3) Notification of Place of Employment

MEXT students who have obtained permission must submit a notification (*Form 1*) to the IAD when they find part-time work.

MEXT students must submit a notification (*Form 1*) to the IAD whenever they change or add a new part-time work.

## 3. Notes

- (1) In some cases, permission is not granted even if an application is filed. You may not engage in remunerated activities prior to obtaining permission.
- (2) Students are permitted to work part-time for up to 28 hours/week (up to 8 hours/day during long holidays).
- (3) Students are not allowed to work part-time during their leave of absence.
- (4) Students may not work part-time in a sexually oriented business.
- (5) Students do not need permission if they engage in an internship for which they are not paid.
- (6) Research students are not allowed to work part-time.
